Regarding Michele Bachmann's HJR 41, that is an exercise in constitutional incompetence. Posturing. The issue, properly framed, is not "currency", but "legal tender". It is already unconstitutional for states to make anything but gold or silver coin legal tender on state territory, and Congress has no power to legislate legal tender on anything but territory under its exclusive jurisdiction, such as federal enclaves (Art. I Sec. 8 Cl. 17) and incorporated non-state territories (Art. IV Sec. 3 Cl. 2). They do it anyway. An appropriately worded amendment would be one like mine, but like any amendment, it is not enough to get it ratified unless it is with massive public support, because it would otherwise just be ignored.

No, she's apparently okay about that (from what I can see from this distance). I was just pointing out that even the good guys in Congress often get it wrong when they try to address constitutional issues. The constitutionality of federal health care is more clear to her than, apparently, something like legal tender.

An example of that was a bill by Ron Paul that would have delegated to the President the authority to issue letters of marque and reprisal. Only Congress can do that -- and only directly. They could issue such letters to the President (and forces under his command), but not delegate the power to him to issue them. (I realize there was a precedent for that during the War of 1812, but they got it wrong then, too.) It would be nice if our champions were constitutionally competent.
