I, Katheryn J. Coggon, declare and testify as follows:

PAGE 1 - DECLARATION OF KATHERYN J. COGGON

1. I am an attorney at the law firm of Holme Roberts & Owen LLP, counsel to Defendants Atlantic Recording Corporation, Priority Records, LLC, Capitol Records, Inc., UMG Recordings, Inc., BMG Music, Recording Industry Association of America, and Settlement Support Center, LLC in this matter. I make the following statements in this declaration based upon my personal knowledge and I am competent to testify regarding any matters set forth herein.

2. My firm and prior counsel to Defendants, in conjunction with the agents we have engaged to communicate with persons whom the Defendants believe infringed their copyrights, have maintained a database in which attorneys or settlement agents record their thoughts and mental impressions about their exchanges with the persons against whom Defendants contemplated or were engaged in litigation.

3. As agreed between the parties to this case, Defendants' counsel reviewed all of the entries in the database pertaining to the roughly 100 residents of Oregon against whom Defendants contemplated or were engaged in litigation (hereafter the "Sample Population"). A very small quantity of entries in the database—less than three percent—are actual or exactlytranscribed written communications with the Sample Population (i.e., electronic mail messages to or from members of the Sample Population or transcriptions of letters to or from members of the Sample Population). The production accompanying this declaration contains all such communications.

4. To the extent that the other entries in the database reflect communications with members of the Sample Population, the memorializations of these communications reflect the subjective mental impressions of the attorney or settlement agent who had the communication. Defendants assert that these entries are protected by the attorney work product immunity.

5. The rest of the database entries reflect exchanges between attorneys and settlement agents concerning how to respond to inquiries from members of the Sample Population. Defendants' counsel assert that these communications entries are protected from PAGE 2 - DECLARATION OF KATHERYN J. COGGON

disclosure by the work product doctrine and, to the extent they also reflect instructions from Defendants themselves, they are additionally protected from disclosure by the attorney-client privilege.

6. Pursuant to this Court's rulings on the privilege and work product issues before it on February 9, 2009, Defendants are providing Plaintiff with the facts respecting Defendants' exchanges with members of the Sample Population, without revealing communications between Defendants and their counsel or the mental impressions of Defendants' counsel.

7. Exhibit A, attached hereto, provides a factual summary of the exchanges with members of the Sample Population that are reflected in the database. It has been revised from the version of Exhibit A accompanying the Declaration of Katheryn Coggon, dated February 23, 2009, to replace the names of Oregon residents with numerical substitutes (i.e. "Oregon Resident No. 1," etc.). Paragraphs 33 and 53 have also been revised to reflect the fact that these individuals have since settled with Defendants.

I declare under penalty of perjury under the laws of the United States of America that the foregoing is true and correct.
