
Your Honor:

I represent the Defendants in the above-captioned matter and send this letter on joint consent of counsel. The parties have reached a Settlement-in-Principal and the underlying paperwork is being prepared for signature. 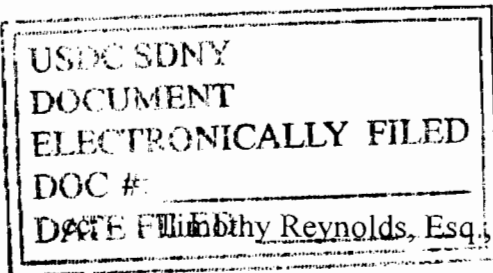
The nature of this joint request is for the completion of the settlement in this action, and is not made for delay or any improper purpose. We therefore ask that the Court grant the requested stay. I remain,
