PLAINTIFF'S POST-JUDGMENT MOTION TO ENFORCE JUDGMENT

Now comes the plaintiff, Recording Industry Association of America and moves that this Honorable Court issue a Summons to bring the defendant, Monica Buckley, before the court so that she can be examined relative to her ability to pay.

1. The plaintiff, Recording Industry Association of America, Successor In Interest to Capitol Records, Inc., a Delaware corporation, Elektra Entertainment Group Inc., a Delaware corporation, Virgin Records America, Inc., a California corporation, Arista Records, Inc., a Delaware corporation, Sony Music Entertainment Inc., a Delaware corporation, UMG Recordings, Inc., a Delaware corporation and BMG Music, a New York general partnership is a corporation duly organized by law.

2. The defendant, Monica Buckley is an individual having an usual place of abode at 228 Sherman Road, Somerset, MA 02726, Bristol County, Massachusetts.

3. The plaintiff alleges that Monica Buckley, named as a defendant in a Default Judgment and Permanent Injunction issued by the United States District Court, District of Massachusetts, Civil Action No. 03-CV-11661-NG and Monica Buckley, owner of the property located at 228 Sherman Road, Somerset, MA 02726, Bristol County, Massachusetts, are one and the same person.

4. The plaintiff brought suit against the defendant in the United States District Court, District of Massachusetts. On December 1, 2004, judgment entered against the defendant in the amount of four thousand, three hundred forty and 22/100 (\$4,340.22) dollars.

5. The defendant has failed to make any payments on the said judgment, leaving a balance due and owing to the plaintiff in the amount of four thousand, three hundred forty and

22/100 (\$4,340.22) dollars, plus interest from December 1, 2004, on or before which date demand for payment was duly made.

6 Many demands have been made upon the defendant for payment of this claim, and she has made no effort to liquidate same.

7. The defendant has been very evasive in her answers as to when payment of this claim can be expected.

8. The judgment remains unsatisfied in full since its issuance from the United States District Court, District of Massachusetts.

WHEREFORE, your Plaintiff moves that this Honorable Court issue a Summons to bring the defendant, Monica Buckley, before the court so that she can be examined relative to her ability to pay.


