**PLAINTIFFS' SECOND UNOPPOSED MOTION FOR EXTENSION OF TIME TO  
RESPOND TO DEFENDANT'S MOTION FOR NEW TRIAL OR REMITTITUR**

Plaintiffs respectfully request a further ten (10) day extension of time, up to and including February 8, 2010, to file their Response in Opposition to Defendant's Motion for New Trial or Remittitur ("Opposition"). Plaintiffs assert that the following circumstances demonstrate good cause for the briefing schedule to be extended through February 8, 2010.
