PLAINTIFFS' NOTICE OF WITHDRAWAL OF MOTION FOR SANCTIONS

On July 6, 2009, Plaintiffs filed a Motion to Compel Defense Counsel to Cease Unauthorized Recording Activities, to Cease Publication of Discovery Materials and For Sanctions ("Motion"). (See Doc. No. 865 in Civ. Act. No. 03-cv-11661-NG.) Among other things, Plaintiffs' Motion sought sanctions against Defendant and his counsel for Defendant's counsel's non-consensual recording of certain depositions and court hearings in this matter. Defendant's counsel also posted some of these unauthorized recordings on the Internet.
