Minute Entry for proceedings held before Robert M. Levy: Richard Gabriel, Maryann Penney; Ray Beckerman. All discovery disputes resolved as explained on the record, some of which are set forth as follows: (1) The parties shall execute the Stipulation regarding Hard Drive Mirror Imaging Inspection forthwith, including only paragraphs 1-6. Defendant shall have the opportunity before the close of discovery to serve contention interrogatories and take expert and fact depositions of plaintiffs' witnesses as to the analysis of defendant's computer. Accordingly, defendant's proposed paragraph 7 is not included in the Stipulation. The inspection shall be completed within 30 days. (2) Plaintiffs shall serve and file a privilege log within 30 days as at the conference. (3) With respect to plaintiffs' interrogatory response 4, the parties agree that plaintiffs are precluded from seeking damages other than those disclosed in their response to interrogatory 4.
